- Required to be a resident of Cardinia Shire (individuals with substantial community contributions to the Cardinia Shire over an extended period who are not currently living in Cardinia Shire may be considered).
- Required to display significant commitment to community services.
- Individuals can only receive the award once in their lifetime.
- Has not been a previously serving Cardinia Shire Councillor in the last four years.

How to Compile Your Nomination

- Nominations must be made using this online form.
- Explain the achievement, background and reasons for the nomination by responding to the questions asked and attaching any supporting documentation.
- Submit the name of at least one other referee in writing to support the nomination.

Submitted information remains the property of Cardinia Shire Council.

Assessment Process

Nominations are assessed by Cardinia Shire Council's Councillors and a representative of the Henwood Family.
